

**PALOMAR DISTRICT  
PROPOSED BYLAWS AMENDMENTS  
TO BE PRESENTED TO THE BOARD OF DIRECTORS ON SEPTEMBER 6, 2019**

**ARTICLE IV – OFFICERS AND THEIR DUTIES**

**Section 3.** (g) The TREASURER shall ....

(g) She shall ~~obtain~~ arrange for the necessary bank signatures cards to be signed by the President, First Vice President, Recording Secretary, Assistant Treasurer, and the Treasurer, with two signatures required to sign checks.

Shall read as: (g) She shall arrange for the necessary bank signatures, with two signatures required to sign checks.

Rationale: Bank policies vary regarding signature cards.

**ARTICLE VIII — DUES AND FINANCE**

Add:

**Section 7.** All monies collected for all special and contracted events, workshops, fundraisers, and seminars shall be remitted to the District Treasurer no later than five working days thereafter.

Rationale: Clarify timeframe when monies should be turned in to the District Treasurer.

**Section 8.** All monies collected for any special CFWC fund shall be remitted by the club treasurer to the District Treasurer who shall notify the District Program Chairman and the District President.

Rationale: Conform to CFWC bylaws.

**ARTICLE X – MEETINGS**

**Section 6.** Voting membership at the Convention shall consist of the voting body of the District. A club whose dues are paid in full shall be entitled to representation by its President or her alternate and one delegate or her alternate for each twenty-five members or major fraction thereof. Affiliate groups may be represented by one delegate at Convention.

Shall read as: Voting membership..... A club whose dues are paid in full shall be entitled to representation by its President or her alternate and one delegate or her alternate for each twenty members or major fraction thereof. Affiliate groups may be represented by one delegate at Convention.

Rationale: Conform to CFWC bylaws.

STANDING RULES:

20. (c) The *Palomar Telescope* shall be sent electronically to all members of the District Board of Directors, CFWC President, CFWC First Vice-President, CFWC Second Vice-President, CFWC Area D Vice-President, CFWC Public Relations Chairman, and Presidents of San Diego and Southern Districts via e-mail. It will be sent via regular mail to those without e-mail.

Shall read as: (c) The *Palomar Telescope* shall be sent electronically to all members of the District Board of Directors, CFWC President, CFWC First Vice-President, CFWC Second Vice-President, CFWC Area D Vice-President, CFWC Public Relations Chairman, and President of Southern District via e-mail. It will be sent via regular mail to those without e-mail.

Rationale: San Diego District merged with Southern District and is no longer a District.
