## PALOMAR DISTRICT ART FESTIVAL



### Narratives Training is Coming Up!

We will be holding Narrative Training sessions right here in Palomar District in November. Almost all of the paperwork in your folder will match last year's instructions. The major change is that the narrative form will specify the 2021 calendar year, January 1 through December 31. (So don't use the 2020 form!!)

The Program Area and Advancement Plan titles will be the same. The only required report is the Statistical Form, but we would love to see at least the Membership Narrative as well.

The judging procedure will match last year's - We will be judging within the District, reading and scoring narratives from non-competing club sizes. There will be some slight changes in the scoring which we will point out.

The Judging process went smoothly, and we are very grateful that your Clubs took care of business on time! Please involve your members in the judging - they will learn a lot about Federation from the carefully crafted reports!

Please send me the name of your club's Judging Coordinator by **November 30th**. This member will be receiving the Narratives from me, arranging for the scoring committee, and returning the scores to me.

Basically, if you accomplished Narratives last year, this year will be almost the same.

If you hear about Dropbox, that change is for me, your District Dean - I will be submitting all the narratives to CFWC on Dropbox. Palomar District Club Deans will submit Narratives to me as attachments to e-mails, just like last year.

## 2nd VP Membership—Bev York

There are several versions of “**A Member’s Bill of Rights and Responsibilities**” by CFWC and GFWC to help us run our clubs smoothly. If everyone knows their rights and their responsibilities as members, the important work we do can proceed without disruption. In this version, which of these rank as the top three rights and responsibilities in priority, based on your experience? No two of us will probably choose the same ones – that’s OK!

### Member’s Rights:

1. Be treated with courtesy and respect
2. Be informed about the purpose, date, time, and place of club meetings
3. Have meetings start on time
4. Participate in discussions, make motions, debate, and vote
5. Have all the facts, alternatives and consequences presented openly and have an opportunity to discuss every item before voting
6. Participate in the process to select officers and representatives
7. Have a copy of the bylaws, standing rules, and all information that’s available to any other member
8. Receive a copy of the minutes
9. See and hear what’s going on and be heard when speaking.

### Member’s Responsibilities:

1. Treat other members with courtesy and respect
2. Refrain from behavior or conversation that hurts or is disrespectful to other members or the club

3. Attend, be punctual, and be prepared for meetings
4. Support and participate in club activities
5. Be informed about the club and GFWC’s [and CFWC’s] mission, services, policies, and programs
6. Pay dues in a timely manner
7. Volunteer personal skills that help the club function effectively
8. Stretch your personal comfort zone and accept leadership roles whenever possible
9. Inform others about the club and GFWC [and CFWC] and bring potential new members to meetings.

These lists were compiled by GFWC Facilitators. Do you agree with them and the orders of priority? Would you add or delete any? They’re not etched in stone so I’d switch some and I expect you would, too. For one, I’d move Responsibility #3 to #1 and move the first two down a notch. To me, attending meetings is a member’s #1 right and responsibility; everything else follows that. I look forward to hearing your amended lists of rights and responsibilities! Include your reasons for the changes if you wish, as a basis for further discussion.

## GFWC Domestic & Sexual Violence Awareness & Prevention— Bev York, District Chair

GFWC recently added more areas and a new name to their Signature Program, **“Domestic and Sexual Violence Awareness and Prevention.”** The focus now is on eight areas: Intimate Partner Violence; Elder Abuse; Child Abuse Prevention; Human Trafficking; Teen Dating Awareness; Campus Sexual Assault; Military Sexual Abuse; Violence Against Native American Women.

**The Alabaster Jar Project (AJP):** We'll continue to collect purses, personal items (none with travel-related logos, please) as well as gently-used clothing suitable for the workplace and job interviews, for AJP, a North County-based resource for human trafficking survivors to rebuild their lives. The project has expanded beyond our original parameters of purses and travel-size personal items, so if your club is not supporting a domestic violence 501(c)(3) project for 2021-22, we'd appreciate your donations! When District meetings resume in person, just bring your

donations to the meeting and I'll collect them there, or contact me to make other arrangements.

If your club knows of a woman who has survived intimate partner violence, is a US citizen or permanent legal resident, is enrolled or plans to enroll at an accredited post-secondary school (community college, technical school or 4-year university) and is recommended by a licensed or accredited domestic violence agency, counselor or social worker willing to provide info on her behalf, GFWC offers a \$2,500 scholarship! ## A Message from Assemblywoman Marie Waldron

As summer comes to an end, the Southern California fire season begins. With dry, hot Santa Ana winds on the way, we must all take extra care to proactively protect our rural communities from wildfires during the dry months ahead.

Unfortunately, many homeowners risk losing or have lost their fire insurance coverage due to living in **Very High Fire Hazard Zones**.

In many communities identified as high fire-risk by insurers, including areas of Valley Center, Fallbrook, Bonsall, Rainbow, Pala, and Pauma Valley, residential insurance is getting harder to find. Many homeowners that receive nonrenewable notices are often forced to seek insurance from another provider at a much higher rate.

If you or someone you know has lost their homeowners insurance coverage due to wildfire risk, my office is here to help by providing a few tips to help you

through the process:

1. Contact local insurance agents or brokers within your area. Use the Home Insurance Finder tool to locate agents in your immediate vicinity and beyond, or click [here](#) to access the Residential Insurance Company Contact List for a list of over 50 insurers that provide homeowners insurance.
2. Ask your insurance agent or broker if they are able to obtain coverage in the "surplus lines" market.
3. If you are unable to find an agent who can insure you, the California FAIR Plan is available to every homeowner as a last resort.
4. If you feel that your insurance nonrenewal was unfair, file a complaint with the CDI.

## LEGISLATION AND PUBLIC POLICY

### New Taxes Down the Road

California has the highest gasoline prices in the country, and at 51.1 cents per gallon, our gasoline tax is also the highest. Keep in mind we have the country's worst poverty rate, with many living just barely above the poverty level, and thousands have real problems just making ends meet. Making matters worse, **SB339** has been signed into law by the Governor. It pilots implementation of a "Road Usage Charge" (RUC) to eventually charge motorists a "per mile driven" tax. We already pay over twice what other Americans pay for fuel and vehicle maintenance – SB339 adds to the burden. Remember, the new RUC will be on top of the existing gas tax, and there's no indication the gas tax will be reduced as the RUC is implemented.

The RUC would replace declining gas tax revenues as motorists shift to Zero Emission Vehicles (ZEVs). But there's a real problem. ZEV owners have a mean annual income of nearly \$200,000/year, 81% are college educated and 81% are homeowners. For the most part, these are not people making two-hour commutes to get to work. Median and low-income commuters are rarely ZEV owners, nor are they likely to be anytime soon. SB339 unfairly shifts the cost of maintaining roads to lower-income drivers and rural communities while giving wealthier ZEV owners what amounts to a 'free ride.'

Gas taxes are constitutionally protected; funds cannot be diverted for non-transportation purposes. No such protections exist for RUC revenues, and history shows funds without constitutional protections can easily be diverted to other uses. Another problem – local jurisdictions, including San Diego County, are considering implementing their own RUC, so the state's travel tax would be in addition to the county's travel tax, on top of the gas tax. California's lower-income drivers should not bear the burden of maintaining our state's highways.
